

King Gee & NZ Safety Blackwoods – 100 Years Promotion

Terms & Conditions:

1. General

1.1 Information on how to enter and prizes form part of these Terms and Conditions ("Terms"). Participation in this promotion is deemed acceptance of these Terms.

1.2 The promoter is NZ Safety Blackwoods, 130 Kerrs Road, Wiri, Auckland, New Zealand ("Promoter").

2. Eligibility

2.1 Entry is open to New Zealand residents aged 18 years or over.

2.2 Employees of the Promoter, its related companies, agencies associated with this promotion, and their immediate families (spouse, parent, child or sibling) are not eligible to enter.

3. Promotional Period

3.1 The promotion commences at 7:00am (NZST) on 1 June 2026 and closes at 11:59pm (NZST) on 30 June 2026 ("Promotional Period").

3.2 All entries must be received by 11:59pm (NZST) on 5 July 2026.

4. How to Enter

4.1 To enter, individuals must during the Promotional Period:

- Purchase any KingGee product from an authorised NZ Safety Blackwoods store or online at www.nzsafetyblackwoods.co.nz; and
- Complete the online entry form at https://crm.nzsafetyblackwoods.co.nz/kinggee_100win; and
- Upload a valid proof of purchase.

4.2 Entrants will receive one (1) entry for each eligible KingGee product purchased.

4.3 Purchases must be paid in full. Accounts must not be in arrears or default.

4.4 Items returned for refund or credit will invalidate the associated entry/entries.

4.5 Entrants must retain their original proof of purchase for verification purposes.

4.6 The Promoter accepts no responsibility for late, lost, incomplete or misdirected entries.

5. Prize Details

5.1 There are 100 prizes to be won:

- Ninety-nine (99) NZ Safety Blackwoods vouchers valued at NZD \$100 each; and
- One (1) grand prize of NZD \$5,000 cash.

5.2 The total prize pool value is NZD \$14,900.

5.3 Prize Payment and Verification

The \$5,000 cash prize (NZD) will be paid via electronic bank transfer to a New Zealand bank account nominated by the winner. The nominated account must be in the winner's name. No currency conversion or alternative payment methods will be provided.

As a condition of receiving the prize, the selected winner must provide reasonable proof of identity and proof of the qualifying purchase.

For purchases made using a business, trade, or company account, the account holder (i.e. the business or entity named on the account or invoice) is deemed to be the entrant and eligible winner, not any individual employee, contractor, or third party.

6. Prize Draw

6.1 The draw will take place at NZ Safety Blackwoods Head Office, 130 Kerrs Road, Wiri, Auckland on 6 July 2026.

6.2 Winners will be selected via a random electronic draw in the presence of an independent witness.

6.3 Winners will be notified by phone and/or email within seven (7) days of the draw.

6.4 Prizes will be distributed within four (4) weeks of the draw.

7. Unclaimed Prizes

7.1 If a prize remains unclaimed 14 days after notification, a redraw will take place on 20 July 2026 at the same time and location as the original draw.

7.2 The redraw winner(s) will be notified within seven (7) days.

8. Verification and Awarding of Prizes

8.1 The Promoter reserves the right to verify the validity of entries and entrants, including proof of identity, age and purchase.

8.2 The Promoter may disqualify any entrant who:

- Submits an entry that is not in accordance with these Terms;
- Tampers with the entry process; or
- Engages in fraudulent, misleading or deceptive conduct.

8.3 The prize will be awarded to the person named in the entry.

8.4 If a winner cannot be contacted or does not claim their prize within the specified timeframe, the prize will be forfeited and redrawn.

9. Prize Conditions

9.1 Prizes are not transferable or exchangeable and cannot be taken as cash, except for the \$5,000 cash prize.

9.2 If any prize becomes unavailable, the Promoter reserves the right to substitute it with a prize of equal or greater value.

9.3 Any costs associated with accepting the prize are the responsibility of the winner.

9.4 Once a prize has been dispatched, the Promoter is not responsible for any loss, damage or delay in transit.

10. Publicity

10.1 By accepting a prize, winners agree to participate in reasonable promotional and media activities, including photography and social media content, without additional compensation.

11.1 To the extent permitted by law, the Promoter is not liable for any loss, damage or injury suffered in connection with this promotion or any prize.

11.2 The Promoter is not responsible for technical errors, lost communications or any issues affecting entry submission.

12. Cancellation or Modification
